Inability to provide home births as requested by the mother and potential patient harm.

Supporting Information (Provides context to the how it relates to the objective, what/why regarding the activity, and/or supporting evidence/analysis to substantiate the risk)

Currently The Home Birth Service is unable to provide a full OOH Service due to a lack of staffing resource. Two x midwives are required to undertake a Home Birth and when this staffing is not available, the OOH Midwife answers emergency calls and requests support from the hospital setting to attend the birth. However, if hospital staff are unable or unwilling to support, the mother is transferred to hospital by ambulance, which increase the risk to mother and baby.

Whilst the trust is exploring a 'Single Point of Access' (SPA) Model, currently emergency calls are transferred to the Acute setting when midwives are undertaking an OOH delivery, but this takes them away from clinical care on the wards.

If NUH is unable to provide mothers with the home birth they request, this leads to poor patient experience and a potential impact on their mental health and post natal depression.

Since X, a total of X incidents have been reported under the Maternity Triggers as a 'Suspension of Home Birth'.

A review on how the Service operates so that any efficiencies in practice can be identified and a more effective Home Birth Service can be given to mothers.

Less than 60% of night shifts had full staffing levels over the last month. Stats: March 21: 29% full staffing, Last 12 months May 20 to April 21: 55% fully staffed, Last 6 months Nov 20 to April 21: 49% fully staffed, Last 3 months Feb 21 to April 21: 38% fully staffed, Stats above showing pattern towards reduction in ability to staff, May 21 - 45% Fully Staffed currently (may change due to sickness and service capacity)

Acute setting staff have to answer emergency calls OOH if both midwives are at a patients home which diverts them from care delivery. Stats for acute setting needing to take calls 2000-2030 (LN shift times) due to staffing; March 21: 19 of 30 dates (63%), Last 12 months May 20 to April 21: 30%, Last 6 months Nov 20 to April 21: 42%, Last 3 months Feb 21 to April 21: 52%

Stats showing pattern towards increase in acute setting needing to take calls.

May 21 – Prediction 45% of nights will need acute setting to take calls as 55% of LN's have no staff rostered currently.
